Merchandise Acceptance is at the discretion of Fun Finds by M and J. Please email pictures of large items for possible consignment to info@funfindsbymandj.com. Smaller items may be brought into the store by appointment on Mondays, Wednesdays, or Thursdays with time slots from 11:00 am to 4:00 pm. **FOR LARGER PIECES PLEASE PLAN ON BRINGING SOMEONE TO HELP YOU WITH UNLOADING/LOADING ITEMS.**

Items should be clean and ready to place on the showroom floor. **We do not accept any items that are stained, have damage or have been exposed to a smoking/pet environment: If discovered after receipt, we will attempt to contact the consignor; if items are not picked up within 48 hours they will be donated.** If an item must be repaired/cleaned, a fee will be added to the consignor account to cover the cost: if damage is unrepairable, we will attempt to notify Consignor by phone and email; after 48 hours item(s) will be discarded. _____ Initials

All items are subject to our markdowns, special sale promotions and store coupons. **It is the Consignor's responsibility to login to their account on the day their items are received to view final pricing of their items.** _____ Initials

A buyer's fee, not to exceed 7% of the original price, will be added to each consigned item. This fee is included as part of the selling price and is added to cover the cost of bags, wrapping paper, bubble wrap, shrink wrap and other expenses related to the sale of the item. All lighting will be subject to a 7% buyer's fee to cover the cost of electricity. The buyer's fee is paid by the buyer and is not subject to the 50/50 split.

Seasonal Merchandise must be picked up by the end of the holiday season/special occasion. (For example: Christmas items would be picked up within 7 days after Christmas.) Any items remaining after this time will be donated.

Consignment Term shall be for a period of 90 days. All items over 90 days will become store property if not picked up by the consignor prior to the 90 days. Consignment term starts when an item is logged into Fun Finds inventory system.

Items will reduce 15% at 30 days; 30% at 60 days at 50% at 75 days. Merchandise left over 90 days becomes property of Fun Finds by M and J and will be donated or disposed of accordingly.

Consignment Term Expiration: It is the responsibility of the consignor to pick up any unsold items before the consignment term expiration (90 days); if they wish to retain possession of the items. Any item(s) not picked up by the consignor by the end of the 90—day consignment period will become the property of Fun Finds by M & J. It is the Consignor's responsibility to keep track of their consignment end date for items they wish to keep.

Items Lost, Stolen or Damaged: All reasonable care will be taken of items consigned with Fun Finds by M & J: However, they are left at the Consignor's own risk and compensation will not be due to any Consignor for lost, stolen or damaged items. We recommend that you notify your insurance carrier that your items are on Consignment.

Consignor Payments for each month's sales will be processed on the 10th day of the month following the sale of their items. All local Consignors must pick up their check at our store location any time after the 10th of the month following the sale. A consignor's check may be mailed if out of state. All funds for any check not claimed or cashed by Consignor within 60 days of the check date will be forfeited and are not replaceable. Please note that a \$2.50 fee will be deducted each month for administrative costs of checks and consignor web access.
